2. Elections Discussion: Lehman Montgomery (15 minutes)

- Met with Jonah (previous Parliamentarian) to discuss refereda, timeline, and penalties.
- Executive Committee and Class Senator elections will be held after Fall Break, which will be after October 17th to the week prior to Thanksgiving break.

- Freshman Class Council elections will still be held in September.
- The timing of spring elections have not been determined.
- Any communications that are sent out to 100+ students requires Lehman to be notified and a disclaimer (stating that students can contact Lehman if they feel like that the communications are unsolicited).
- Students interested in creating a referenda can have an unlimited number of people helping collect signatures.
 - This rule does not apply to elections.
 - Anyone helping collect signatures are subject to the same electronic communications rules

Questions from the Senate:

- Does the 100+ student communication rule apply to posting in Facebook groups?
 - Yes, Lehman should be notified if students are posting in Facebook groups larger than 100 students. Emails being sent out to over 100 students should CC Lehman.
- Is \$50 still the limit for each student's campaign?
 - Yes, but conversations about spending have not been finalized yet. The Elections Committee is still trying to figure out how to limit spending for third parties.
