Description and Objectives

The Menstrual Products Project Team is a continuation of the Menstrual Products Project Task Force that led the 2-week menstrual products pilot in Frist two years ago and has been working on campus implementation since 2018. The goal of this task force is to finalize implementation of University-provided menstrual products in academic building restrooms (female, male, and gender-neutral).

Current Members: Wendy Zhao (U-Councilor), Mike Asparrin (Former Class of 2019 Senator), Katharine Fleming (PSGE), Preeti Iyer (former U-Councilor, PSGE), Sarah Pacilio (PSRJ, Planned Parenthood Campus Campaign), Ruby Guo (Former Class of 2019 Senator)

We hope to invite anyone on campus who is interested in the project team, whether on USG or not, to come to our meetings and help us make free menstrual products on campus a reality.

Background Information

Menstruation is a basic biological function, and students require access to menstrual hygiene products to maintain a healthy lifestyle. Without guaranteed access to these products, the ability of students to perform - academically and socially - is disrupted. Students who cannot afford products suffer a financial burden each month.

It is important to our mission and to the student body that menstrual products be available in bathrooms regardless of gender assignation.

Students have demonstrated overwhelming support of free menstrual products being provided on campus, with students echoing that free menstrual products should be inclusive for all genders and should be provided regardless of the likelihood to use it.

Potential Activities, Deliverables and Timeline

Right now, we've secured financial quotes from two Manufacturers (after figuring out how the contracts would work specifically for Princeton) and are waiting on funding approval from VP Calhoun, and a final confirmation of logistics feasibility from Facilities. The proposal for this year is to start implementation in 56 campus academic / student life bathrooms, and to have those bathrooms stocked for the foreseeable future. Once there is a better understanding of the project / how Princeton differs from industry standard, we will pursue expansion.

CHARTER OF THE CAMPUS AND COMMITTEE AFFAIRS COMMITTEE

Ratified:

ARTICLE I – NAME

The Committee shall be named the Campus and Community Affairs (CCA) Committee of the Princeton Undergraduate Student Government (USG).

ARTICLE II -- PURPOSE

201. Campus and Committee Affairs

The CCA Committee will strive to organize events and foster relationships that connect members of the Princeton University campus with one another and the greater community. The CCA Committee emphasizes the collaborative nature of strategic partnerships on and off campus that facilitate a more inclusive, accessible, welcoming campus and community.

202. Communiversity

The CCA will represent the undergraduate community in the planning, coordinating, and implementation of an annual Communiversity arts event. It will work closely with the Director of Community and Regional Affairs and community partners to create the “town and gown” event.

203. Civic Engagement

The CCA will promote civic engagement on campus in partnership with community stakeholders. Civic engagement includes campus-related advocacy, activism, and service that is political or non-political in nature, subject to the discretion of the Chair in liaison with CCA membership.

The CCA will coordinate the undergraduate student body’s non-partisan voter engagement efforts for campus, local, state, federal, and international level elections, subject to the discretion of the Chair in liaison with CCA membership.

Any concern of the motivation behind or goal of a particular initiative may be questioned by the formal, written request of any one USG Executive Committee (ExComm)

Member. A review of the initiative will be taken in an executive session of the USG Senate and approved or rejected by a majority vote of the USG Senate.

ARTICLE III – MEMBERSHIP

301. Membership Defined

The CCA Committee shall consist of a maximum of fifteen members: the CCA Chair, the CCA Vice-Chair, a maximum of three seated members of the USG Senate, and a maximum of ten other students, selected and confirmed with an effort to ensure class year representation.

302. Membership Selection

The CCA Committee Chair will coordinate with the USG President and USG Vice President to recruit members during USG's recruitment cycles at the beginning of each semester.

At the start of each semester, the CCA Committee Chair may opt to extend membership to seated Committee members in good standing and to select a Vice Chair for the Committee. The CCA Committee Chair must consult the seated CCA Committee members prior to offering membership to new individuals; however, the Chair maintains ultimate discretion over the selection of applicants.

Once selected by the CCA Chair, each member must be confirmed by the USG Senate. Upon appointment, the CCA Committee member shall undertake full responsibilities as defined by this charter.

303. Membership Responsibilities

Members must regularly attend and actively participate in meetings throughout the semester. Absences will be excused only with valid excuse provided in advance of missing a meeting, except in cases of emergency.

Each member must participate in at least one sub-committee each semester. Members may propose a community-building initiative as a sub-committee at any point during the semester. The initiative is active so long as a majority of present membership supports the proposal.

The Chair reserves the right to assign Sub-Committee roles to members with exceptional commitment, interest, and skill-sets related to particular tasks, including but not limited to group advising, outreach, partnerships, and logistics. Members will interact with student groups outside of meetings as necessary per their assigned roles.

Any CCA Committee member with unexcused absences from two regular meetings in a given semester or exhibiting a general failure to adequately discharge enumerated/assigned duties, may be dismissed by the Chair. This decision can be appealed and brought before the USG Executive Committee, which will subsequently conduct a review in consultation with the

Chair and Committee members. If the bodies do not reach a consensus, the appeal can be brought to the Senate which will make a final decision by majority vote.

304. Vice Chair Responsibilities

The CCA Committee Chair may choose at their discretion to designate one member to serve as Vice Chair in addition to their regular membership responsibilities. Any seated member in good standing is eligible to be appointed by the Chair for a term of at least one full semester. The appointment is confirmed by a majority vote of the CCA Committee membership.

The CCA Committee Vice Chair executes authority delegated by the Chair in accordance with this Charter. The Vice Chair will assume the duties and responsibilities in the place of the Chair's absence. The Vice Chair's primary function is to assist the Chair in the day-to-day operations and management of the Committee, its members, and its initiatives.

305. Chair Responsibilities

The CCA Committee Chair serves in accordance with the USG Senate Constitution as a voting member of the USG Senate and as an Executive Officer. The Chair's primary role is to lead the CCA Committee with vision and organization in accordance with this Charter and the USG Senate Constitution.

The Chair responds to the CCA Committee membership and Executive Committee of USG. The Chair can be subjected to a review of reprimand by the Executive Committee upon a signed petition of at least $\frac{2}{3}$ of the CCA Committee membership or upon a signed petition of at least $\frac{2}{3}$ of Executive Officers of the USG Senate.

ARTICLE IV – MEETINGS

401. Regular Meetings

The CCA Committee must meet a minimum of 8 times each semester, at the discretion of the CCA Committee Chair. A quorum ($\frac{2}{3}$ of members) must be present to make significant and substantial decisions regarding Communiversity or communications with the Princeton University Director of Community and Regional Affairs.

Records and agendas of every regular CCA Committee meeting must be maintained and updated by the CCA Committee Chair or delegated to a designated member. These documents must be accessible to all seated CCA Committee members, future members and Chairs of the CCA Committee.

402. Open Meetings

The CCA Committee may hold open meetings to engage community stakeholders at its discretion.

ARTICLE V – AMENDMENTS

This Charter may be amended or altered in consultation with the Chair of the CCA Committee by a majority vote of the USG Senate.

ARTICLE VI -- CHARTER RATIFICATION

Upon a 2/3 vote of the USG Senate, this charter shall be considered established and operational.

Additional ideas:

Article on Funding Allocation (\$1000 less and Senate funding?)

- As mandated in the USG Constitution, the CCA Committee Chair and the CCA Committee shall communicate regularly with the Director of Community and Regional Affairs to discuss and explore solutions for issues facing Princeton University and community relations.

Promote Community Relations

- “Community” is defined as agents, beneficiaries and groups of individuals otherwise involved or affected by the operations of Princeton University; expansive enough to include residents of the town of Princeton and Princeton employees. (peer institutions/college students)
- “Campus” is defined as students, faculty and members of the academic and social community at Princeton University.
- This task incorporates events such as Restaurant Week - an event that allows students to interact with businesses and stakeholders in the town of Princeton.
- Any initiatives, ceremonies or events oriented toward engaging stakeholders in the town of Princeton and the immediate community members of Princeton (student, staff, faculty, etc.) falls within the purview of this task.

The Senate's Place in the University

Second Princeton University Charter (September 14, 1748)

“George the Second, by the grace of God, of Great Britain, France and Ireland, King, Defender of the Faith, etc., to all to whom these presents shall come, greeting—

...

“[W]e...will, ordain, grant, and constitute, that there be a college erected in our said province of New Jersey, for the education of youth in the learned languages and in the liberal arts and sciences...”

**Second Princeton University Charter
(September 14, 1748)**

“...the trustees of the said college and their successors for ever, may and shall be one body corporate and politic,...and shall be called, named and distinguished, by the name of THE TRUSTEES OF THE COLLEGE OF NEW JERSEY...”

Trustee Resolution (October 27, 1927)

- (1) Resolved, that the Board recognize the Student Council as the official representative body of the undergraduates.
- (2) Resolved, that opportunity will be afforded the Student Council for consultation with the appropriate Committees of the Board of Trustees or the Faculty before final action is taken on matters of undergraduate life.
- (3) Resolved, that subject to action of the Faculty, the proposal that the Student Council be represented on the Discipline Committee and the Committee on Non-Athletic Organizations, be approved.

**Excerpt of Trustee Statement on Delegation of Authority
(October 24, 1969)**

“...Oversight of student life and discipline, including the formulation of rules of conduct and dormitory regulations, has been delegated to the President and Faculty to be exercised through various Faculty and student groups *in accordance with duly constituted procedures.*”

Kelley: U-Council founding father discusses group's ten-year history

After four years, Professor of Politics Stanley Kelley Jr. is back in the midst of his own creation. A decade ago, a university body officially titled the Committee on the Structure of the University—but less formally dubbed the Kelley Committee—proposed what eventually became the University Council.

The founding father served on the body during its first several years before taking a four-year break. But in 1978, Kelley was elected again to the U-Council and returned to find that it had gotten along quite well without him.

For while he concedes there are some problems, Kelley believes the U-Council has generally performed well in its role as a deliberative and advisory body.

"Quite a number of important issues have been brought up in the U-Council that have been worked out to people's reasonable satisfaction," Kelley said. The body's success could well be attributed to the experience and skill of the hand that crafted it. The

white-haired, pipe-smoking political scientist has chaired several campus committees that have had profound impact on the shape of the university—including the one that recommended Provost William G. Bowen's selection as president of Princeton.

'Influential member'

That president's assistant, T. Dennis Sullivan '70, recently described Kelley as "one of the most influential members of the faculty."

However, Kelley himself attributes the U-Council's long-term health to the approach his committee took in setting it up ten years ago.

We weren't going to start immediately talking about institutions," Kelley said of his committee. "We took areas of policy one by one—disciplinary procedures, budget-making, investment issues—and decided how we could best make decisions in those areas and who should be in on them."
